# NATIONAL REGISTRY OF CERTIFIED MEDICAL EXAMINERS

Licensed Medical Examiners, including MDs, DOs, NPs, PAs and DCs, who perform DOT CMV driver physical medical exams are expected to fully understand the medical requirements and guidance established by the Federal Motor Carrier Safety Administration (FMCSA). In order to become certified, to perform DOT physicals, the FMCSA requires medical examiners to participate in an accredited training program, register with the National Registry and pass the national certification exam.
